Examination Topics:

The CEICC and CEICI closed book examinations cover **five topic areas** relevant to environmental infection control consulting and investigation. The CEICC exam contains 120 multiple choice questions; the CEICI exam contains 100 multiple choice questions. 1. Infectious diseases and their modes of transmission in the institutional setting
2. Principles of infection control during construction, demolition, renovation and repair activities
3. Infection control project management
4. Effective infection control practices during construction, demolition, renovation and repair activities
5. Respiratory Protection
